The new DC can be safe in the knowledge that they are making a real difference to local young people by working with a team of like-minded adults to develop the District

Why is this role important?.

The DC will be responsible for ensuring adults have what they need to be confident in their role by creating a network of support to help and guide them. They will have access to training relevant to the role and will have an induction to ensure they get the very best start. The DC will also form part of the County Management Team and be involved in setting the strategic direction that the County will take over the coming years.

How do you nominate or apply?

Full Role Description

To manage and support the Scout District to ensure it runs effectively and that Scouting within the District develops in accordance with the rules and policies of The Scout Association so that that the District provides good quality Scouting for young people and proactively supports and manages adults in the District.

Responsible to: County Commissioner (or deputy if appropriate).

Responsible for: Deputy District Commissioners, Group Scout Leaders, District Explorer Scout Commissioner, District Scout Network Leaders, Assistant District Commissioners, District Scout Active Support Managers, District Scouters, District Advisers, Nights Away Advisers, District Media Development Manager.

Main contacts: County Commissioner, Deputy District Commissioners, Group Scout Leaders, District Explorer Scout Commissioner, District Scout Active Support Managers, District Scout Network Leaders, Assistant District Commissioners, members of the District Executive Committee and its sub-committees, County Scout Network Commissioner, County Training Manager, Local Training Manager, members of the Regional Development Service, Local Development Officers, other District Commissioners, members of the local community, schools and other youth organisations.

Appointment requirements: Must complete the relevant mandatory training (and a wood badge) as soon as possible of taking up the role. Must be eligible for charity trustee status (as a member of the District Executive Committee). It's expected that whilst volunteering for this role you will undertake regulated activity.

Main tasks:

- Ensure that the District thrives and has the best systems in place to support the Groups, to support all adult volunteers in the District and to develop Scouting in the District.
- Provide line management and support to the adults in the District that directly report to you including setting objectives for their work and holding regular reviews and one-to-one meetings.
- Produce a vision for the District and implement a development plan to meet that vision.
- Ensure that Scouting in the District is attractive to young people and adults from all backgrounds in the District.
- Ensure that the District has an adequate team of supported and appropriate adults working effectively together and with others to meet the Scouting needs of the area.

 Work with the County and other District Commissioners in the County to ensure that the Scouting in the County thrives.

Some of the tasks for which the District Commissioner is responsible may be delegated to others in the District, including a Deputy District Commissioner, if appointed.

Information about being a Charity Trustee

You cannot be a Charity Trustee if

- have an unspent conviction for dishonesty, deception, bribery, money laundering, terrorism, misconduct in public office, perjury, perverting the course of justice, aiding, attempting or abetting any of these crimes.
- have an IVA, debt relief order and/or a bankruptcy order
- have been removed as a trustee in England, Scotland or Wales (by the Charity Commission or Office of the Scottish Charity Regulator)
- have been removed from being in the management or control of any body in Scotland (under relevant legislation)
- have been disqualified by the Charity Commission
- are a disqualified company director
- are a designated person for the purposes of anti terrorism legislation
- are on the sex offenders register
- have been found in contempt of court for making (or causing to be made) a false statement
- have been found guilty of disobedience to an order or direction of the Charity Commission
- you are under 18 years of age
